This Business Sales Letter of Agreement and any other written materials provided to Member (as defined herein) from time to time (collectively, the "Agreement") sets forth the terms and conditions of the Business Sales Program of Euromarket Designs, Inc. d/b/a Crate & Barrel and CB2. The Business Sales Program and the Agreement are subject to change from time to time at the Company's discretion.

Once eligibility is met, and subject to the terms of this Agreement, Members participating in this Business Sales Program will receive a membership discount on full-price merchandise purchased at Crate and Barrel in the United States, excluding all Outlet locations. Rights and rewards under this Agreement are nontransferable.

### **TERMS OF ELIGIBILITY**

An applicant who meets the criteria will be eligible for participation in the Business Sales Program (and referenced herein as a "Member") upon approval by the Company after presentation of the following:

1. A **Business Card** indicating the applicant's business;
2. A completed and signed **Application** form; and
3. Either: a) a copy of the applicant's **Business License**; or  
b) a **business tax identification number**

- Members must present their Business Sales member number with identification at time of purchase to count toward Member's annual spend.

### **MEMBERSHIP**

- Member's name and business address must be provided on the application. Note that the eligible Member must be an individual and not a business or entity; multiple individuals employed by a single business or entity may apply individually by submitting individual application material and gaining approval, but the business or entity itself may not become a Business Sales Member.
- It is the responsibility of the Member to notify the Company of any changes in his/her contact information. Members can update their information by calling a Business Sales Representative at 800.717.1112.
- Member is the only person authorized to make purchases using his/her account number and Business Sales Card.
- The Company reserves the right to make all membership determinations at our sole discretion.
- Incomplete applications will not be accepted.
- Employees of the Company are not eligible for membership.
- The Company reserves the right to review and terminate a Member's eligibility if the Company believes, in its sole discretion, that Member has violated the terms of this Agreement. Company will notify the Member that they are no longer eligible to participate in the program.
- Members may cancel their membership at any time by calling a Business Sales Representative at 800.717.1112.
- Lost or stolen membership numbers may be canceled and replaced at the Company's sole discretion. Please call a Business Sales Representative at 800.717.1112 to request a new number.
- Company may discontinue program at any time and at Company's sole discretion.

### **DISCOUNT**

- Discount applies only to full-price merchandise for purchase in the U.S. through the Company's U.S. stores or through the Business Sales Department at the then-published retail price. Discount is non-negotiable.
- Discount is not applicable to purchases of Gift Cards, eGift Cards, services, shipping and handling, taxes or other fees and non-merchandise charges.
- Discount does not apply to any purchases made prior to enrollment in the Business Sales Program.
- Discount may not be combined with any other offer, coupon or promotional program and cannot be applied to reduced price, sale, closeout or clearance merchandise.
- Outlet merchandise is not eligible for discount.
- Prices for merchandise eligible for discount are set for each item and are non-negotiable.

- Merchandise eligible for discount is limited to the merchandise available for sale in the U.S. or through the Company's U.S. stores and Business Department.

#### **PURCHASE AND PAYMENT TERMS**

- To make a purchase in stores, the Member must present his/her Business Sales member number along with an accepted form of picture ID (e.g., driver's license, state ID).
- Member will be responsible for payment of any and all taxes, service charges and other fees on the discounted amounts, in accordance with any applicable laws and regulations.
- Product returns are subject to the applicable return policy and will be credited (as applicable) at the membership discount rate.
